**International Student Tuition is due in full August 15<sup>th</sup>. Cash, cashier’s check, or money order will be accepted. No credit cards.**

**Tuition and billed fees are due on the 1<sup>st</sup> of each month. Account payments not received by the 5<sup>th</sup> of the month will be assessed \$25.00 late fee.**

Full account payment not received by the last day of the month will result in student's suspension from school until full payment due is made. Parent/Guardians will be call to pick up student(s) who have been dropped off when no payment has been made. If Parent/Guardian can not or do not pick up the student(s) when called to do so, Child Protective Services may be called to pick up the student(s). Each student's account must be current in order for the student to participate in field trips. The C.C.S. Board will consider delinquent accounts on an individual basis. Tuition may be paid with cash, personal check, credit card, money order, or cashier's check (credit cards are accepted, but please note published costs are the cash and check discounted rate). All returned checks will be assessed a \$25.00 additional fee. If a personal check is returned, the next payment will require a cashier's check, cash, or money order.

### **PARENT INVOLVEMENT PROGRAM (PIP)**

The PIP program requires that each family donate twenty (20) hours of involvement time throughout the school year. A buy out option of \$200 is also available. At the end of the year, if all 20 involvement hours (PIP Hours) have been completed, the \$200 charge will be credited. ALL 20 hours must be completed for the credit to be applied. PIP CAN NOT be prorated.

### **CRYSTALCATHEDRAL SCHOOLS EXTENDED DAYCARE**

C.C.S. is a closed campus.

C.C.S. students must be supervised while on campus.

C.C.S. provides supervision from 7:00 AM to 6:00 PM. C.C.S. students (K-8) must remain in the extended Daycare Program until a parent (or person authorized by a parent.) signs them out. Students must be in your care once they have been signed out of daycare. Do not leave your students on playground or in the building unattended.

High School Students are required to leave campus (the Family Life Building) as soon as school is dismissed or the after school programs they are involved in are over.

HOURS: 7:00–8:00 AM & 3:30–6:00 PM

FEES: \$1.50 per ½ hour or any part thereof.

BILLINGS: Charges will appear on your monthly statement. Payment is due upon receipt.

SIGN OUT: Parents of children grades K–8<sup>th</sup> must sign-out their child(ren) when picking them up. ALL students must stay in designated daycare area until signed out by the parent/guardian. Failure to sign student(s) out will result in being charged until 6:00 PM. Exception: Students on authorized Drive Thru list that have been picked up in drive through.

### **CCA STUDENTS CAN NOT BE LEFT BEFORE 7:00 AM OR AFTER 6:00 PM!**

***To discourage supervision before 7:00 AM or after 6:00 PM parents will be charged A DOLLAR A MINUTE before 7:00 AM or after 6:00 PM. Parents making a habit of dropping off early or picking up late will be asked to make other daycare arrangements.***
